## ESD Alliance Membership Requirements and Types

The Electronic System Design Alliance (ESD Alliance) is a SEMI Technology Community. Membership in the ESD Alliance requires an active and current membership in SEMI. There are no additional member fees required to join the ESD Alliance.

### VOTING MEMBERSHIPS

Voting members are companies engaged in providing goods and services to the semiconductor electronic system design ecosystem. Common examples include EDA and Semiconductor IP suppliers. Membership entitles your company to vote on the selection of ESD Alliance Governing Council members, policies, have employees participate or serve as an officer in ESD Alliance committees and working groups, use of the ESD Alliance's logo in promotions, receive invitations to meetings, and receive all pertinent correspondence.

### NON-VOTING MEMBERSHIPS

Non-voting members include organizations not actively engaged in providing goods and services to the semiconductor electronic system design ecosystem, but which are often customers of products and services from voting member companies and/or are associated with and interested in the design ecosystem. Common examples include IDMs and fabless semiconductor companies or electronics product manufacturers, high-performance computing suppliers, cloud services providers and license management software suppliers. Non-voting memberships do not include voting rights nor the ability to nominate candidates to serve on the Governing Council. Non-voting membership does entitle employees to serve on committees and working groups, attend most meetings, use the ESD Alliance logo in promotions and receive all pertinent correspondence from the ESD Alliance.

### APPROVAL OF MEMBERSHIP

Per the ESD Alliance Bylaws, all membership applications (whether for voting or non-voting membership) must be approved by a 2/3 majority of the [ESD Alliance Governing Council](#).
